Welcome to Saint Lucia

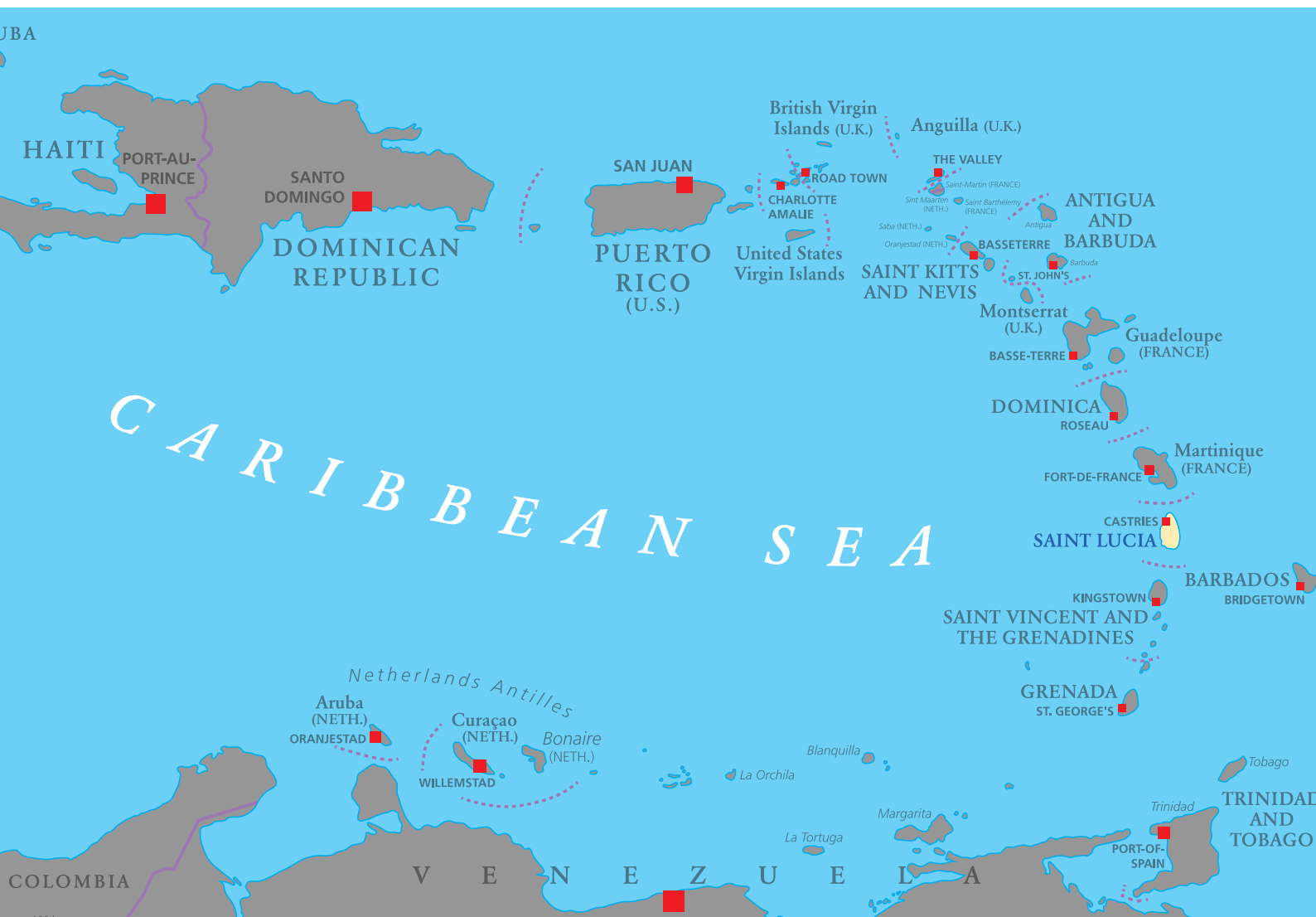
St. Lucia is a jewel of the Caribbean Sea. It is one of the Windward Islands of the Lesser Antilles, lying north-northeast of Saint Vincent, northwest of Barbados and south of Martinique.

A relatively small island of 617 square kilometres, Saint Lucia is approximately 43km long and 23 km wide. It is a (dormant) volcanic island covered in lush rainforests and ringed by reefs and sandy beaches and is, in every sense, an unspoilt tropical island paradise.

Saint Lucia has a tropical rainforest climate, moderated by northeast trade winds. The average daytime temperature is 30°C all year round, with a dry season running from December to May and a rainy season from June to November.

The population of Saint Lucia is around 180,000, with a mixed African, East Indian, French, and English cultural heritage resulting in a rich Caribbean culture.

Saint Lucia is a politically stable, constitutional monarchy with an elected bi-cameral and a legal system based on common law. It has a developing economy, with tourism as the GDP's most significant contributor and a thriving service sector.
